**DEED OF VARIATION  
of the Supplemental Funding Agreement  
for Queensbury Academy**

THIS DEED OF VARIATION is made on

2018

**BETWEEN:**

- (1) The Secretary of State for Education of Sanctuary Buildings, Great Smith Street, London SW1P 3BT (the “Secretary of State”); and
- (2) CfBT Schools Trust, a charitable company incorporated in England and Wales with registered number 07468210 whose registered address is at Highbridge House, 16-18 Duke Street, Reading, RG1 4RU (the “Company”)

together referred to as the “Parties”.

**INTRODUCTION:**

- (A) The Parties entered into a supplemental funding agreement on 30 August 2012 relating to the establishment, maintenance and funding of a school known as Queensbury Academy (the “Academy”).
- (B) The Parties then entered into a Deed of Variation on 19 December 2014 to update the supplemental funding agreement to the latest Department for Education model for the Academy (the “Existing SFA”).
- (C) The Parties now wish to further vary and amend the terms of the Existing SFA and wish to record their agreement as to such amendments to the Existing SFA by this Deed to update the capacity and age range.

**IT IS AGREED** as follows:

1. The Secretary of State and the Company agree that with effect from the date of this Deed the Existing SFA shall be amended and restated in the form set out at Schedule 1 to this Deed.
2. As varied by this Deed, the Existing SFA shall remain in full force and effect.
3. This Agreement shall be governed by and interpreted in accordance with English law.

This document has been executed and delivered as a Deed on the date stated at the beginning of this Deed.

Amendments to the Existing SFA for Queensbury Academy

Clause 2.5 A of the Existing SFA shall be deleted and replaced with “The planned capacity of the Academy is 1350 in the age range 11-19, including a sixth form of 250 places.”
